Inflatable Bounce Castle

SAFETY RULES

- 1. OUR BOUNCE CASTLES ARE ONLY RATED FOR CHILDREN 12 YEARS OLD AND YOUNGER. NO ONE OVER THE AGE OF 12 IS PERMITTED IN THE BOUNCE CASTLE!
- 2. A RESPONSIBLE ADULT IS REQUIRED IN ATTENDANCE AT ALL TIMES!
- 3. Canton Chair Rental is not responsible for any damage to property or persons that may occur in connection with the installation of bounce castles. IF DURING OPERATION, THE WIND BECOMES EXCESSIVE (20 MPH), UNLOAD OCCUPANTS AND DEFLATE. For the safety of all, evacuation is always recommended in threatening weather or if there is any doubt concerning the safe use of the bounce castle.
- 4. Riders should be grouped according to age and there should be no more than 6-7 riders at one time. The maximum capacity is 1250 lbs.
- 5. No shoes are allowed on the ride. All participants should be in stocking feet only.
- 6. All riders must empty pockets, remove eyeglasses, jewelry, necklaces, and any hard objects before entering the ride.
- 7. No flips, somersaults, wrestling, or other forms of rough housing while on the ride.
- 8. No climbing or hanging from outside walls.
- 9. No one is allowed on the ride while it is being inflated or deflated.
- 10. Do not allow riders closer than four (4) feet from each other.
- 11. This ride is not to be used when raining or wet. Do not spray water on the ride for any reason while it is in operation. No silly string or glitter is to be used.
- 12. Persons not obeying the safety rules should be asked to leave.
- 13. This ride is sports-like in nature. Participants understand that they are responsible to evaluate any physical or mental condition that could jeopardize their safety during its use. You should not use this ride if you have any of the following conditions: pregnancy, current or previous back or neck injury, any type of heart or respiratory condition including but not limited to asthma or bronchitis, chronic knee or other joint conditions.
- 14. The use of alcohol or drugs is prohibited!
- 15. No smoking allowed either in or around this ride!
- 16. Do not allow any children or adults at any time near the electric blower fan, power source or extension cord while in operation.

The state of Ohio considers bounce houses an amusement ride (1711.50 Ohio Revised Code). For the safety of all concerned, Canton Chair Rental is committed to following all laws and requirements issued by the Ohio Department of Agriculture regarding the bounce castle.

Ohio Law (1711.531 Ohio Revised Code) states that amusement rides cannot be connected to alternating current (AC) unless they have written certification that the fusible switch, enclosed circuit breaker, or panel board has been approved by a State of Ohio certified electrical inspector or a State of Ohio licensed electrical contractor. *The law requires a written certification from the event sponsor/facility owner*.

Event sponsors/facility owners (including homeowners) should have written certification on hand. If the certification is not available, you should contact your local building authority, building contractor, or your electrical utility supplier.

Because it is the law, Canton Chair Rental *does* notify the Ohio Department of Agriculture of all bounce castle rentals and locations of events (1711.53 Ohio Revised Code). A representative of the Ohio Department of Agriculture (ODA) may do a site inspection. A written certification should be on site at the time of inspection.

Therefore, the undersigned agrees that the fusible switch, enclosed circuit breaker or panel board to which the bounce castle(s) will be connected, has been approved by a State of Ohio certified electrical inspector or a State of Ohio licensed electrical contractor.

Customer agrees to follow the rules and requirements. Customer will be responsible for all fines issued if the rules and requirements are not met.
